






How to access reports

Follow these steps to access and run a report:

- Log into EmployerAccess at **anthem.com**.

 If you don't already have a log in, select **Register Now**.
- Choose **Support & Resources** tab from the top left menu drop down.
- 3 Select Reports & Tools.
- Choose **Tools & Resources**, then **Anthem CDHP and FSA Reports**. A new window will open; select the **Menu** icon.
- 5 Select **Reports** and then **Request**.
- Once you've run a report, go to the menu, select **Reports**, **Results**, and then **View Results** to see your report.



- Includes or excludes dependents.
- Includes sub-accounting and divisions (if applicable).


Employee account details report

- Provides an overview of enrollment and YTD fund utilization on plans.
- Shows information for reimbursement accounts.
- Provides transparency and visibility (shows which employees owe money back to the plan for ineligible expenses).

Settlement reports

Employer disbursements report

Plan types:

- Flexible Spending Account (FSA)
- Health Reimbursement Account (HRA) with debit card option (member-pay HRA)
- Dependent Care Account (DCA)
- Parking and transit commuter accounts

What the report does:

- Reconciles all claim activity for a time frame, except for HRA provider-pay claims.
- Gives a consolidated, accurate report of spending activity for relevant plan types.

Employer account reconciliation

Plan types:

- FSA
- HRA with debit card option (member-pay HRA)
- DCA
- Parking and transit commuter accounts

What the report does:

- · Reconciles employer bank accounts.
- Provides a daily overview of all debits and credits to your account.
- Offers the capability to show a specific time period and display totals of your deposits, manual claims, and point-of-sale (POS) debit card transactions against an employer account during that time period.
- Displays a beginning and ending employer account balance.

Claims-based funding report

Plan types:

- FSA
- All HRAs (member or provider pay HRA)
- DCA
- Parking and transit commuter accounts

What the report does:

• Reconciles a list of transactions that were included in claims-based funding.

 Provides an overview of HSA enrollment status, including accounts still in CIP review.

HSA-funded contribution report

Plan type: HSA

What the report does:

- Confirms the status of payroll contributions submitted within a specific date range.
- Helps you easily confirm if contributions were posted successfully.
- Provides failure reasons for unsuccessful file uploads.

HSA payroll reconciliation report

Plan type: HSA

What the report does:


- · Reconciles payroll files.
- Provides a list of payroll-funded HSA credits within a specified date range.
- Reconciles employee and employer contributions.

Employer HSA summary report

Plan type: HSA

What the report does:

- Provides YTD summary of contributions and transactions.
- Provides account status.
- Displays YTD summary of account usage and investment activity.
- Determines plan efficiency and opportunities for additional education.


